

4D3N KUALA LUMPUR + GENTING

OVERVIEW

This five-day itinerary highlights Malaysia's cultural and historical heritage. It starts with a full-day tour of Kuala Lumpur's landmarks like the Petronas Twin Towers and the National Mosque followed by a full-day excursion to Batu Caves and Genting Highlands. The trip concludes with leisure time before your departure.

Day 1: Arrive Kuala Lumpur

- Genting Highlands where you can enjoy a ride in the fastest and longest cable car in South-East Asia. Chin Swee Caves Temple (Buddhist temple)

- Lunch and dinner at local restaurant (own expenses).
- Overnight at Kuala Lumpur hotel.

Day 4: Departure (Breakfast)

- Breakfast at the hotel.
- Free and easy until driver pick up to airport.
